ABOUT THE URBAN COUNTY CHARTER COMMISSION

By: David Campbell, Vice Chair of the Urban County Charter Commission Here's your choice...vanilla in a cone or vanilla in a cup. Which do you choose? Not much of a choice, is it?



That's the choice the Urban County Charter Commission has served up to the voters of Bernalillo County. Do you want the current county government, or do you want the same look, taste, feel, and temperature as the current county government?

A year ago, voters throughout New Mexico gave Albuquerque and Bernalillo County the right to begin a process to bring about fundamental reform in the city and county's local government's structures and functions. It was a two-step process, each step being independent of the other.

First, create a commission to recommend a new form of Bernalillo county government, designed to meet the needs, demands and standards of county governments in the 21st century. Then, ask county voters to vote on the proposed new "Urban County Charter".

Next, whatever voters decided on the Charter, begin another commission to recommend the combination or "unification" of the city and county governments. In so doing, we could make local government more efficient and eventually have it run better and cost less.

The new "Urban County Charter" has just been drafted by the Urban County Charter Commission (UCCC). Unfortunately, it is anything but "new and improved". After working for 8 months, the UCCC has produced a very disappointing document. It is a mirror image of the existing county government; with all of the 19th century inefficiencies built in. As former UCCC Chair Barbara Seward put it, the Commission missed a "once in a century opportunity" to bring about fundamental reform in a government which was much in need of it.

If the County Commission chooses to place this draft document before the voters in December, I will recommend that it be defeated, as being an antiquated government model that is far less than what the citizens deserve.

The good news, though, is that this failure by the UCCC has not slowed the pace of movement toward the unification of city and county governments. This will be a good thing for Sandia Heights and other currently unincorporated areas of the County.

Why? Here's why:

- 1. Collectively, Sandia Heights residents spend millions in sales taxes in the City of Albuquerque when they buy groceries, haircuts, furniture, and any other goods or services there. With few retail or service establishments east of Tramway, residents must shop in Albuquerque.
- 2. Sandia Heights taxpayers don't have a real voice when it comes to determining where those taxes get spent because they don't live and vote within the city limits
- 3. Many Sandia Heights residents drive daily on Albuquerque's city streets and highways, and pay for them with the gas taxes and sales taxes paid in the City. But Sandia Heights residents don't have any say at all about how and where those streets are built, maintained, or used.
- 4. Sandia Heights residents don't have any representation in determining the leadership, direction, training or funding for the police officers that enforce the laws and provide emergency services while Sandia Heights residents are in Albuquerque.
- 5. None of those millions of sales tax dollars paid to the City of Albuquerque come back to benefit homes on the east side of Tramway in Sandia Heights.

This is the dilemma of taxation without representation. Sandia Heights residents pay through the nose for a government that will always and only treat them like visitors or tourists because they don't have a voting address within its city limits.

The good news is that this is all about to change. In 2002 or 2003, the City and County will begin a process leading to the unification of these two governments. A commission of 11 members chosen from the city and county will begin meeting to draft a charter for a metropolitan government, one that will represent the citizens of the entire area we now know as Bernalillo County. It will be a challenging job, but one that should capture the interest of people from Sandia Heights and throughout the County. I want to encourage you to take part in this process and bring about a 21st century local government.




Members of the Sandia

Covenants Control Committee

The committee has met twice since the new board was formed and we have added one new member, Bob Francis. We have decided that the first order of business is to organize the work of the committee and streamline the operations. We will accomplish this in several ways, as follows: A standardized complaint form will be used for all complaints. This form will be available at the SHHA office or may be downloaded from the web site.

Complaints will only be accepted from Current members of SHHA. No anonymous complaints will be accepted. All complaints must be delivered to the SHHA office in person or by US Mail and must be signed by the complainant.

Legal research is being done to see if the resident making a complaint must live in the unit in which the alleged violation of the relevant covenant occurs. The complaint must site what covenant the complainant says is been violated and the specifics of the violation.

The committee will review the complaint and determine if there is a violation. Objective criteria will be used in viewing the complaint. Valid complaints will be assigned to a committee member for resolution. We will contact the offender three times. The first contact will be by phone or in person if possible to try and negotiate and inform the alleged violator. If personal contact is not possible then a Certified, return Receipt US Mail letter will be sent to the violator with a due date for response.

A second certified letter will be sent if there is no, or a negative, response received within two weeks. If no response or a negative response is received a third and final letter will be sent informing the violator that the violation will be referred to the legal advisor for further action.

If a complaint is rejected by the committee, a letter will be sent to the complainant explaining the reason for rejection. The committee is currently processing the complaints on file. All current complaints will be processed.

Effective August 27th the committee will only accept complaints filed using the new procedures.




Life in the Fast Lane

Imagine walking along San Rafael where it crosses Laurel when a car whizzes by you at 55 MPH. That wouldn't happen in Sandia Heights you say. We live in a residential area. Well, if you were there at 3:00 in the afternoon of May 2, a car traveling west on San Rafael was clocked at 55MPH. Just an anomaly you think? Well at 1:00 and 5:00 on the same afternoon, cars traveling east on San Rafael were also clocked at 55 MPH.

These were the most excessive speeds clocked during the traffic speed study done by Bernallilo County at the request of the SHHA but these examples were by no means the only instances of excessive speed. The study was performed between noon May 1, 2001 and 2:00 P.M. May 4, 2001. The results clearly show speeds far in excess of the posted speed limits as you can see from the graph below.







During the three days of the study, over 90% of the cars were traveling in excess of the posted 15MPH speed limit. Less than 25% of the cars were traveling at 20 MPH or less. More than one out of every two cars was traveling at speeds greater than 25MPH. In an area such as Sandia Heights where the roads are narrow, have blind is very dangerous.

Even nighttime when visibility is substantially reduced and you would expect people to slow down didn't make a difference. The speed profile between the daytime hours and the nighttime hours was essentially identical.

So, what does all this mean? We MUST reduce our speed when traveling through our community. If we don't do it voluntarily, then measures such as increased enforcement and speed bumps must be taken. None of us speed in our community could mean serious injuries or even a fatality.

What can you do right now to help this situation?

If you're a driver — slow down! By slowing down, you will also help others slow down. At 15 MPH it will take you four minutes to travel one mile. At 55MPH, it will take you one minute and 5 seconds. Are the time savings you if you were involved in an accident caused by excessive speed? What would be the personal consequences to you of getting a speeding ticket?

If you're a pedestrian – walk safely! Walk against traffic whenever possible. This will give you the best chance to see an oncoming car and get out of the way. Wear light or reflective clothing at night.



Highlights of the minutes of the July 11th Board of Directors Meeting

Guest rangers from the US Forest Service said they will work with property owners to resolve issues about trespassers. The Forest Service will look for opportunities to improve public access to the National forest. And since their funding is limited, they rely on volunteers to help keep paths clear. Fire is always a possibility in Sandia Heights, and while the rains help diminish the risk, owners are urged to use good housekeeping measures around their homes to keep the vegetation at a minimum.

The President of the Board, Don Aunapu indicated that the SHHA office is to be used for board and committee work, but that other neighbors' offices, like the churches and Futures for Children, are available for use by homeowners for other non board meetings.

Harris Goodwin, Chair of the Covenant Control Committee, indicated that new forms are available to report complaints, but all such must be in writing and signed by the complainant.

Traffic and Safety Committee Chair, Eric Nuttall, reported that a survey of San Rafael showed the average speed to be 35mph, with greater speeds reported, for a street with a posted 15mph limit. This is a serious issue for the committee and several enforcement efforts will be put in place to keep our residents safe.

Beginning August 13 overgrown vegetation on San Rafael, Bobcat and Deer will be trimmed by the county, unless owners request that their property not be trimmed. Vandalism was a serious problem in March and April and security measures are being implemented to discourage any further misdeeds.

THE COUNTY, CHAMISA AND SIBERIAN ELM REMOVAL**WHY?



Many residents have called or written with complaints about the county cutting the Chamisa and Elm trees along the County owned road right of ways. In Sandia Heights the County owned road right of ways are at least 50 feet wide, the pavement is usually 20 feet wide, that means that we do not own the land right up to the pavement. Our property line is on an average 15 feet away from the pavement. It is their property and their responsibility to keep it clear and safe.

Not only are Siberian Elm trees against most of the covenants in Sandia Heights, they are a deadly traffic hazard when growing close to the edge of the pavement. Many being removed are big enough to cause serious damage to a car or to cause death if a car was speeding when it hit the tree.

The Chamisa growing out over the road are a hazard to walkers, bikers and auto drivers. In some cases they extend over 4 feet into the right of way.

These pictures tell the story of their hazard to life and limb



On the left the Chamisa have overgrown the Pavement by 4 feet, on the right they have been cleared



A person walking, a car, a double line no passing zone, and Chamisa overgrowing the pavement, not a very safe situation, is it?



Another example of Chamisa growing over the pavement, a double line, no passing, no place to go when a car and a walker meet.



This is another problem, blocking of intersections by trees and bushes. This is a violation of the Zoning Code and property owners must keep these cut back, even if it is on county owned property

Bears are on the prowl, 2 were recently reported here in Sandia Heights, here are some things to know:

[Bear information from 1995 Sandia Mountain Bearwatch Grit article]

- 1. Keep your trash in sturdy, closed containers. Keep trash cans clean and non-smelly. Put trash out on the morning of pickup.
- 2. Don't feed pets outside, Don't store food outside.
- 3. Feed only enough birdseed to last the day. Bring in hummingbird feeders at night. Remember to feed suet and peanut butter to birds only in winter when bears are in hibernation.
- 4. Keep barbecue grills clean and stored inside.

- 5. Don't add melon rinds or fruit to compost piles except in winter.
- 6. Don't feed wildlife.
- 7. If you have fruit trees or berry bushes, in dry years you may have bear visitors at night. Be compassionate and know that this comes from living in or near mountains. 8. If you see a bear near your home call Sandia Security at 263-4654, Bernalillo County Animal Control at 873-6706 and/or NM

Rattlesnakes up to 5 feet long have been spotted near the foothills:


If you see a snake, leave it alone, call Sandia Security 263-4654

Keep your garbage in tight containers or inside.


Check openings like a dryer vent, make certain they are screened.

Letters to the Editor: Policies by: Jim Cook

The GRIT welcomes and encourages members of the Sandia Heights Community to submit "Letters to the Editor" of not more than 400 words. This is your opportunity to be heard by the entire community. Topics should be of interest or importance to the Sandia Heights Community. Submissions should be sent to the SHHA office by email, postal mail, fax, or may be dropped off in person during SHHA office hours. Letters must be submitted by the first of each issue's publication month (currently February, April, June, August, October, and December) in order to meet publishing schedules.

Submissions in electronic form (email text or Word Document format) are preferred but legible printed or typed submissions will be accepted if time for retyping is available. Letter authors must identify themselves and provide a phone number for verification of authorship and permission to publish. The GRIT will not publish anonymous letters and will not withhold the name of a letter author. A brief overview of the major policies covering "Letters to the Editor" is provided below. The complete policy statement is available at the SHHA Office during SHHA office hours.

Letters are accepted subject to space limitations. Letters not published because of space limitations will receive precedence for publication in the next issue if the topic is still timely and relevant.

Letters will be edited for minor spelling, typographical, and grammatical errors. If a letter requires major revision before it can be accepted for publication, it will be returned to the author with comments on revisions required for the letter to be considered for publication.

Good manners and common courtesy must be observed in all submissions. Letters with vulgarity, mean-spirited or insulting terms, accusations, and libelous or potentially libelous content will be rejected.

Criticism of the SHHA or items published in the GRIT is acceptable, even encouraged, so long as the criticism is constructive, not mean-spirited, and does not personally attack anyone.

Letter writers may have no more than one letter published per issue and precedence will be given to less frequent letter writers if space limitations prevent publishing all letters submitted for a given issue to encourage participation by the entire community.

The GRIT will publish letters with differing viewpoints in rough proportion to the number of letters received from each viewpoint if all letters cannot be published because of space limitations.



- 5. Let members know covenants are readily available at the office and on the website and the ACC/Covenants Administrative Assistant is available to discuss the covenants during office hours.

Possible activities for attracting new members and developing a sense of community discussed were:

- 1. Picnic for SHHA families, like in days of yore, at either Elena Gallegos or high Desert Park
- 2. Ballroom or Country Western dances for members, with instructors demonstrating
- 3. A musical occasion, perhaps at Futures; a Wassail, with medieval music; a concert by the High Desert Pipers; a local chamber music group or a local dance band.
- 4. An arts/crafts juried show or an antiques fair in conjunction with the annual Wine Tasting.
- 5. A carnival for the kids in Sandia Heights. Bring in the fire trucks, face painters, perhaps a pony ride. Get parents involved to help plan.
- 6. Sandia Pueblo wishes to invite our residents to visit their old village. Set up a committee to facilitate this.
- Explore the possibility of obtaining tram discounts for our members. Also investigate whether the same could be arranged for the Sandia Amphitheater.
- 8. Create a "What's Happening" column in the Grit which will regularly list the activities of all clubs in the area.




