Winter Tips for Melting Ice and Snow

Being close to the Sandias in Sandia Heights, we often deal with more snow and ice than the rest of the city, and it can occur unexpectedly due to our unique ecosystem. If you want to melt the ice and snow, you may be tempted to use old-fashioned inexpensive rock salt, but it can be lethal to pets and wild animals if ingested. In addition, it is only effective at temperatures around 20° and higher.

Calcium chloride or magnesium chloride are more effective at lower temperatures. Magnesium chloride is preferred, as it is safer around animals in addition to being environmentally friendly. Sand or kitty litter are two other options to consider. Whichever you choose, be sure to remove as much snow and ice as possible first, follow the instructions, spread your granules evenly, and store the product in a place where children or animals cannot access it.

Additional hints:

- > Store in an airtight container or heavy duty
- Remember that most ice melt products also damage plants, driveways, and concrete.
- > Do not spread with bare hands! Apply with broom, spreader, or a cup.



Odds & Ends from Parks & **Safety Committee**

As everyone who has lived in Sandia Heights for a while knows, we can get some pretty bad weather in winter, particularly in December, that leaves our roads treacherous For those who may be new to the neighborhood this is a reminder that our roads are OWNED and MAINTAINED by Bernalillo County. Your homeowners association has absolutely NO authority to do anything about the roads when they are totally iced over.

The county policy for bad weather is: "The most heavily traveled roads are prioritized first. As an example in the Sandia Heights area, Eubank and Paseo Del Norte would be a priority because of the number of cars that use it." In talking to them there

really is no time schedule and they usually work the storm as it develops. This being the policy, the best advice is to stay home the morning after a storm, if at all possible, safe and warm, until the ice on the streets begin to melt and it is safe to travel.

Pedestrian Safety Reminders

- Walk on the left side of the road Facing Traffic; make eye contact with drivers approaching you.
- Wear reflective vest or brightly-colored clothing, particularly in the evening.
- If you are walking a dog, keep the dog to your left.
- Whenever cars approach, a group of pedestrians should walk in **single file**.



Movie Reviews by "The SHHA Couch Potato"

This month, we kick off a new feature for folks who prefer to enjoy their movies at home instead of at the local multiplex. For our first article, we'll look at three newly released action films that tap timely themes while offering plenty of antihero action. Of these films, one is merely good, one is better, and one is truly best.

Good: "The Take," directed by James Watkins, stars Idris Elba as a CIA operative saving Paris from terrorists who are not what they seem. There is a fine movie buried in here someplace, but there are also enough plot holes to make a couch potato head for the kitchen instead of watching bullets flying and bodies dropping. Richard Madden gives a strong performance as a pickpocket with a heart of gold, Charlotte Le Bon is believable as a bomb mule with a heart of gold, and Idris Elba is terrific as a rogue CIA agent with (what else?) a heart of gold. Terrorism in Paris provides a timely backdrop for the action, and Watkins even throws in some fake news as a contemporary plot device. But despite its many features, this movie is mostly cotton candy, i.e., it's tasty enough to satisfy as a buddy movie, but with no real lasting nutritional value.

Better: The fourth installment of the Bourne Trilogy, the eponymous "Jason Bourne." Director Paul Greengrass and superstar Matt Damon resurrect the series they both swore they would never revisit, and we are well-served by their decisions to return.



Jason Bourne is back, this time with his memories restored and loaded for bear, so the plot has plenty of non-stop mayhem. Tommy Lee Jones provides some old new blood as a CIA chieftain, and Alicia Vikander offers a welcome dose of young new blood as an enigmatic intelligence agent with a hidden agenda or two. Julia Stiles reprises her supporting role as Nicky Parsons, and there are plenty of ties to newsy topics du jour, including mass demonstrations, terrorism, and political intrigue.

Best: David Mackenzie's "Hell or High Water." Here, the action is lifted straight out of the classic western bank-robbers-on-horseback genre, but with our antiheroes riding in stolen cars instead of on hooves. Chris Pine gives a star turn as one of two brothers trying to save the family ranch, and Ben Foster is terrific as his ne'er-do-well sibling. Jeff Bridges livens up the action as a grizzled Texas Ranger, and his law-enforcement partner is played to pitch-perfection by Gil Birmingham. The storyline is right out of today's financial-page headlines, and the cast of characters is populated with bad-guy bankers, gun-toting depositors, and sub-prime financial worries that drive the compelling plot. It's one of the best movies of 2016, and it's the top choice this month for a discerning couch potato's quality time in front of the tube.

Coyotes By Anne Manning

When we moved our family to Sandia Heights back in the early nineties we were excited to find coyotes amongst our neighbors. At night we would hear them yipping and howling as they ran through the arroyo near our house. We knew that there were enough rabbits to feed, not only the coyotes, but also our hunting cat. She used to leave parts of the rabbits she caught on the kitchen steps in the garage. I was also fortunate enough to see the same coyote just about every day as I walked early in the morning. He would appear on the west side of Tramway, which at that time had not been built over, and cross the highway near where I was walking. As time went by, the rabbit population diminished and the covotes gradually disappeared – at least in my neighborhood. Back in July 2016 I ran across a fascinating book: "Coyote America – a Natural and Supernatural History" by Dan Flores who describes the life and mystical significance of the covote in North America. It is an amazing book that I would recommend to anyone interested in these magical animals.

One day, recently, as I was returning from my morning walk up Live Oak on the west side of Tramway, I saw a coyote, my first in years, waiting beside the road at the intersection. There was quite a lot of traffic and I was concerned that he would just run across and get hit. But the light changed, the traffic stopped and the coyote, who was aware of my presence, crossed the road. When he got to the east side of Tramway, he walked up a little slope towards the park, stopped, turned his head and looked straight at me with an expression that clearly said, "I'm good, you didn't need to worry." Then he headed up Live Oak! Wow, what a gift!

MAIL THEFT

Sandia Heights Security says that mail theft is still a problem. Residents are advised not leave mail in mailboxes, either incoming or outgoing. If you cannot retrieve your mail promptly ask a trusted neighbor to get it for you. If you are leaving town suspend your mail delivery - have it held at the Post Office.

If you have mail that would be considered sensitive, you may want to mail it at a USPS office. Another suggestion might be to replace your mailbox with either a heavy duty locking type or totally enclosing the box with acceptable construction and a lock to impede vandals as well as thieves.

Please be alert to anyone in a vehicle checking mailboxes. A license number on a vehicle along with a vehicle description would go a long way to putting an end to this activity. If you experience mail theft, notify the BernCo. Sheriff's Office (BCSO) (798-7000), the USPS inspector (1-877-876-2455), and Sandia Heights Security (856-6347 and 263-4654). If you witness a crime in progress notify BCSO and Security.





LIGHT REMINDER

We are receiving an increase in lighting complaints and suspect this is due to security concerns from our residents. Unfortunately, we all moved into a neighborhood with no street lights, restrictive covenants, and within the Bernalillo Light Pollution Ordinance. The covenants and Ordinance restrict your outside lights from intruding on your neighbors' property. There is no waiver for all-night security lighting.

Part of the charm of Sandia Heights is the ability to enjoy the night sky. It is suggested that you look at alternative means for security protection other than with lights. If you have guests over please remember to turn the outside lights off as soon as possible. Lights should remain off after 11:00pm and must be aimed to *prohibit the light from leaving your property*. When the covenants were initially written in the 70's, there weren't any high intensity LEDs or Quartz lights; however, the CSC will consider these newer technologies as "flood lights" in our enforcement of lighting complaints. A little light goes a long way in our neighborhood.

TRASH CANS

Trash containers, visible from the street, are also a major source of complaints. The trash bins should be wheeled behind a fence or screen or put in the garage. The containers may be put out on the day before collection in the late afternoon but must be stored after the trash is picked up. At this time of year we also generate more paper and boxes then will fit into our recycle bins. If this is your case then consider using some of the off site recycle bins throughout the city (found on the BERNCO web site) or divide the load up for two pickup cycles. You can also call Sandia Heights Services and ask what other options, such as special pickups, can be arranged.

PARKING

Most all of the covenants address cars that have not moved from a <u>lot</u> or <u>driveway</u> or are unlicensed. These may be a covenant violation for which the CSC will investigate. However, we do get complaints about cars parked on the street or in communal parking areas. The CSC does not handle these parking issues and they should be referred to the Sheriff's Department. SHHA does not have the authority to enforce parking on county roads or common areas. The Sheriff can and will tow cars at the owners expense. Once towed it may be difficult or expensive to reclaim your car, so be mindful of where you park.


